## **Privacy Policy**

### 1. We respect your privacy

- 1.1. Safeguard Security Specialists Pty Ltd respects your right to privacy and is committed to safeguarding the privacy of our customers and website visitors. We adhere to the Australian Privacy Principles contained in the *Privacy Act* 1988 (Cth). This policy sets out how we collect and treat your personal information.

# 2. Collection of personal information

- 5.5. This information may be disclosed to a potential purchaser under an agreement to maintain confidentiality.
